Description

Eliquis[®] is selective inhibitor of Factor Xa.

Policy/Criteria

Provider must submit documentation (such as office chart notes, lab results or other clinical information) supporting that member has met all approval criteria.

It is the policy of health plans affiliated with Centene Corporation[®] that Eliquis[®] is **medically necessary** when the following criteria are met:

I. Initial Approval Criteria

- **A.** Meet one of the following indication:
 - 1. Diagnosis of one of the following (a, b, c, d or e):
 - a. Reduce the risk of stroke and systemic embolism in patients with nonvalvular atrial fibrillation
 - b. Prophylaxis of deep vein thrombosis (DVT),
 - c. Prophylaxis pulmonary embolism (PE)
 - d. Treatment of DVT
 - e. Treatment of PE

Approve Duration 6 months

B. Other diagnoses/indications

1. Refer to the off-label use policy for the relevant line of business if diagnosis is NOT specifically listed under section III (Diagnoses/Indications for which coverage is NOT authorized): CP.PMN.53 for Medicaid.

II. Continued Therapy

- **A.** (must meet all):
 - 1. Currently receiving medication via Centene benefit or member has previously met initial approval criteria;
 - 2. Member is responding positively to therapy

Approve Duration 12 months



B. Other diagnoses/indications (must meet 1 or 2):

1. Currently receiving medication via Centene benefit and documentation supports positive response to therapy.

Approval duration: Duration of request or 12 months (whichever is less); or

2. Refer to the off-label use policy for the relevant line of business if diagnosis is NOT specifically listed under section III (Diagnoses/Indications for which coverage is NOT authorized): CP.PMN.53 for Medicaid.

III. Diagnoses/Indications for which coverage is NOT authorized:

A. Non-FDA approved indications, which are not addressed in this policy, unless there is sufficient documentation of efficacy and safety according to the off label use policies – HIM.PHAR.21 for health insurance marketplace and CP.PMN.53 for Medicaid or evidence of coverage documents.

DVT: deep vein thrombosis PE: pulmonary embolism

Appendix B: Contraindications/Boxed Warnings

Active pathological bleeding or severe hypersensitivity reaction to Eliquis®.

V. Dosage and Administration

Indication	Dosing Regimen	Maximum Dose
Reduce the risk of stroke and systemic embolism in patients with nonvalvular atrial fibrillation	5 mg orally twice daily Age greater than or equal to 80 years, body weight less than or equal to 60 kg, or serum creatinine greater than or equal to 1.5 mg/dL, the recommended dose is 2.5 mg orally twice daily	10 mg/day
Prophylaxis of DVT and PE following hip or knee replacement surgery	2.5 mg orally twice daily	10 mg/day
Treatment of DVT and PE	10 mg taken orally twice daily for 7 days, followed by 5 mg taken orally twice daily	10 mg/day
